



Safety Accredited Contractors: Forecourt Passport Scheme

- Ensures contractors are trained in basic health and safety practices
- Passport Scheme is 10 years old: passports expire after three years and must be renewed
- A one day refresher course renews the passports

What is it?

A Forecourt Passport verifies that the holder has completed an oil industry certified two day training course covering general health and safety practices. In particular the Passport course teaches about the practical issues of identifying potential hazards, safe work practices and controlling a work programme on a petrol station.

Why complete the scheme?

In order to ensure high safety standards are met, it is now required to be a Forecourt Passport Scheme member before entering and working on any major oil company petrol filling station in the UK. The training applies to all areas of a petrol filling station, including the shop. For instance, tradesmen planning to work within the shop of a petrol filling station must hold a passport to demonstrate awareness of possible hazards within a petrol filling station.

Course details

The training is delivered over two days: the core day is common to all industries, whereas day two covers health and safety issues specific to the industry in which the contractors work.
